How is this conversation not political when so far all we are being shown is negative impacts that are "well established" but only anecdotal with no peer reviewed studies? Ex. You can't test cannabis on pregnant women so there is no proven link between cannabis and birth weight.

There are actually quite a number of studies on cannabis in pregnancy. I would refer you to the ACOG website (American College of Obstetricians and Gynecologists) to see their position statement. There is a well referenced statement there. The statements made were not meant to be political- I have tried to quote the medical literature from large peer reviewed studies.

Actually I started out feeling that way. However it is a regular occurence to see patients with psychotic symptoms that do indeed have tragic consequences. These were not present prior to legalization. I believe the higher potency is certainly a component of this. Perhaps we are better at recognizing this than prior but I think the increased prevalence of these presentations outweighs this benefit- just my personal opinion.

Wouldn't it help avoid paranoia if we can regulate adult cannabis products with proper dosage, rather than our children getting it on the street in unknown concentrations?

I also felt this way initially. However it has not really been regulated as I would have hoped. Products approach 99% THC in dabs and there is no known dosing. Flower percentage of THC has gone from about 2% to 20%. If it went through a pharmacy I believe that may be the case but as it stands, it goes through a dispensary which in comparison to a pharmacy is unregulated. Pediatric poisonings by poison center calls for cannabis have gone up yearly since legalization.

Has research specifically tied these symptoms/rates to THC? Has research included CBD use?

I am not sure specifically what symptoms you may be referring to but ongoing research is trying to discern what may be impacting that. There seems to be clear correlations with increasing THC% and symptomatic severity and frequency of occurrence. As far as how the other components what are in cannabis such as CBD may affect this, as far as I am aware there is ongoing research into this.

Psychologist Erik Erikson talks about addiction in relation to essential satisfaction. I was curious about your take on that. Essential satisfaction is what most people feel if they live in a society that meets their basic needs for four things: belonging, identity, meaning and purpose. When these needs are not met, humans are prone to addiction. We know that our society is increasingly fractured and that the consumer society we were raised to cherish is actually making us sick. How do you make sense of this in your research?

I think that is interesting. Certainly substance dependence is multi-factorial. To be clear I am ER doc and not an addiction psychiatrist. However I do believe that what you mentioned makes sense. Any addiction or substance dependence are related to abnormalities in dopamine functioning in the the brain. Dopamine is also related to happiness and satisfaction. This would make sense to me from that standpoint.

I will look more closely into this one. I know the requirements to operate come from the State level, locally, our inspectors review standards for septic and pesticide use and making sure the facility itself is sanitary. However, the State Department of Revenue addresses the requirements for business. If I'm unable to find this before the meeting ends, I will provide information to Alison for follow-up afterward

Our county does provide ACEs screening with new parents through hospital and non-profit referral. There have been no formal studies regarding indirect correlations between parents' use of cannabis and ACEs scores.

We do! Our substance abuse coalition talks about this often in our treatment of substance dependence in general. I do not know if this has been looked at for THC specifically. I think that would be a great area of future research.

Comment on the chronic absenteeism rate in Pueblo. Dr. Randall in Nov. 2019, showed slides discussing - 38% chronic absenteeism. Has this improved? If so how and what initiatives were undertaken?

Yes- Dr. Randall is one of my partners. COVID has certainly derailed any chance of knowing what is happening! Our schools do struggle with poverty- which I believe is the largest driver. My personal take is that for this to improve, we need our poverty rates to decrease. I do believe that substance abuse- no matter the substance- adversely impacts employment opportunities. To that end, our substance abuse coalition in Pueblo has gone to the middle schools and has given presentations to multiple schools on substance abuse in general and that has been very well received. I don't know if that answers the question but my take.

The honest answer is I don't know. It's an interesting statistic but beyond that I don't know that I can elaborate further. I would imagine it is likely multifactorial.

In Colorado, is there any negative impact on towns who choose to allow for cannabis sales if the towns receive Federal funds for any reason?

We will look into this and provide a follow-up answer with Alison to send out to the registrants. As mentioned during the presentation, a lot of the studies are being presented and relayed in real-time.

Additional follow-up: Additional, non-biased/more focused studies would need to be conducted to relay information. Some evidence explains taxing revenues federally. Costs to communities are not accounted for in this information sharing. Other studies and information shared have a industry-focused bias which do not take costs to community into consideration. It would be important to contact local planning and development officials to look more closely into this and how it could impact local towns/communities.
